ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 18)

TSEUNG KWAN O—LAM TIN TUNNEL

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, cycle tracks, central reserves/refuge islands, amenity areas and open space within the limit of works area as shown on Plans Nos. TK2377 to TK2385 ('the Plans') and described in the scheme annexed thereto, and as amended by Amendment Plans Nos. TK2378A and TK2382A ('the Amendment Plans') and described in the amendment scheme annexed thereto. The Plans and scheme were referred to in G.N. 2569 published on 10 May 2013 and 16 May 2013. The Amendment Plans and amendment scheme were referred to in G.N. 4090 published on 23 June 2017 and 30 June 2017. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 15 August 2020 to 14 August 2021, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, cycle tracks, central reserves/refuge islands, amenity areas and open space to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a dual two-lane highway (of which part is in the form of a tunnel) between Lam Tin and Tseung Kwan O South, the construction of slip roads, depressed Road P2, Lam Tin Interchange and Tseung Kwan O Interchange and the realignment of a section of the existing footpath leading to Junk Bay Chinese Permanent Cemetery, as well as other ancillary works.

This notice will be affixed on or near the affected carriageways, footpaths, cycle tracks, central reserves/refuge islands, amenity areas and open space on 31 July 2020.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—

Personal Information Collection Statement
